### 2. ANNUAL FEE FORMULA

- c) For game fees regarding exhibition games involving *foreign teams*, please refer to Rule 19 of the Canada Soccer Rules and Regulations.
  - i. Games involving a Professional Club in Membership as a % of gross gate receipts (including taxes) **8%**
  - ii. Games involving non-member clubs as a % of gross gate receipts (including taxes) **10%**

**10. INTERNATIONAL AMATEUR CLUB FRIENDLY TOURNAMENTS**

- a) Administrative Fee **\$100.00**

**11. OUTSTANDING INVOICES**

- a) 18% interest per annum (1.5% monthly) applied to outstanding levies and all invoices over 30 days. No interest will be charged if payment is received within 30 days of the date of the invoice.
- b) Payment for Travel Costs for National Club Championships to be received immediately upon receipt of invoice (7 days grace accorded).
